CPI recommends the proper recycling of all electronic items to minimize the impact of these materials on the physical environment around us.

Great strides have been made worldwide in the recycling of electronic components, including PCBs and other commonly used components found in high powered amplifiers. However, the actual main Vacuum Electron Devices (TWTs and Klystrons) still require specialized processing for proper recycling of those components.

CPI has partnered with a recycling firm based in the USA to properly recycle used TWTs and Klystrons. The following firm is prepared to receive these used materials and process them at no charge to CPI's customers, aside from shipping charges to send the material to them.
